## **Chairman's Comments**

Unfortunately this was two less than our official complement and therefore at our last council meeting we co-opted P Burrow and G Willetts. With five new councillors we have sufficient new blood and fresh ideas to take the council forward, fully utilising the hard won experience of the senior councillors. We will be reviewing all of our services at a special brainstorming meeting to set our plans for the forthcoming 4 year term of office.

## **Land at Ashley**

The Deed has now been signed that confirms our rights to benefit from any future development of this land, at present designated as open space. However our legal costs in confirming our position have to be recovered. This is in progress with the other parties concerned .

## **Vandalism in the Parish**

We continue to suffer from vandalism especially around the Village Hall area and playpark. We have recently had to repair the gate from Braeside Road into the playing field. Expensive pea gravel, installed for safety reasons in the playpark, appears to be diminishing rapidly. Children's rides are being senselessly damaged. This cannot continue especially as the safety regulations regarding all items in the park are being upgraded. This may require substantial expenditure so that we comply with enhanced safety laws. The Village Hall Management Committee may be installing a CCTV system which will give us more control of the activities in the playpark and surrounding areas.

The year has been a success academically with very good results in the assessment of our Key Stage 1 pupils - that's the first 3 years of education. This a great tribute to our staff.

There have been significant improvements to our school security with better control of access into the building and success in finally getting the boundary fence increased in height along that portion of the pathway leading to the school which is hidden from view - this has long been a matter of concern. The remainder of the fence will be replaced as funds permit.

St Ives School Association continues to provide enormous support for the school and raise

considerable sums through its range of activities - the Strawberry Fair was a particular success! This year they have, happily, managed to find a lifeguard for the summer and are able to open the swimming pool to the community - see below - this is an asset which the Parish should make every effort to maximise. ### **Results and information a recent survey**

Recently a survey of the areas of concern for local residents was undertaken and it has now been collated.

By far the greatest concern was law and order and as your Police Authority member I have arranged an appointment with the Chief Constable to try and address some of the problems.

The next concern was the Health Service, which unfortunately cannot be addressed at local level.

The Environment was the next concern. East Dorset District Council has given an additional £12,000.00 to enable them to increase the litter picking programme and the problems on the A31 are being looked into. Transport and Street lighting were also

concerns and I am going to ask the Parish clerk to put them on an agenda as soon as possible for your councillors to discuss a way forward.

However, refuse, car parking and education although mentioned did not appear high on anyone's concerns. These issues will be monitored. Of the three questions asked about Council Tax, the vast majority of you asked for the tax to be kept as low as possible but not to reduce services. On the question of the B3081 slip road a majority of you wanted a filter lane whilst mini roundabouts and traffic lights were not a high priority. Addressing these issues will be a slow process because unfortunately it takes ages to achieve success. The Environmental problems all cost megabucks but we are working hard to get these issues into the budget programmes.

### **HACB Ringwood and Fordingbridge**

I wonder how many readers will know what HACB stands for? Some people instantly think it is the 'listening bank' but then realise that the letters are slightly different!

Hampshire Association for the Care of the Blind – HACB for short, is an association for people with visual impairment. The association offers advice to those who have recently experienced sight problems or sight loss, and to relatives or friends of such a person. The loss of normal sight can be a very distressing and confusing time and it is not always clear where one can turn to for help.

Those living in the BH24 area are entitled to belong to the association and information can be obtained by phoning Mary Peach the Branch Secretary on 01425 470008 or Eric Love the Chairman on 01425 480057.

The club holds regular club sessions on the second and fourth Thursday afternoon of each month, with the exception of August, from 2 pm to 4 pm. An afternoon tea with sandwiches and cake is provided, together with some form of entertainment- a speaker, musical entertainer or quizzes. Transport can be provided for those who need it. During school term time, craft classes are held every Thursday morning from 10 am to 12 noon. Again transport can be requested.

The club (formerly known as the Ringwood Blind Club) is a very friendly place to meet and enjoy each others company. You do not have

to be registered blind or partially sighted just having sight problems is enough.

The volunteers also find it very satisfying and rewarding. Volunteers are always welcome and at the present time HACB Ringwood and Fordingbridge Branch is looking for :

After several months waiting for Ofsted to finalize our registration, Christopher Chope, the M.P. for Christchurch, took notice of our plight. As a result of this St Claire's is now a fully registered childcare provider. This means we can stay open until 6:00 and parents can claim Working Families Tax Credits towards the cost of fees.

The Lions of Ferndown and Wimborne have been kind enough to lend us use of their mini-

bus allowing us to pick up from St Ives First School, Three Legged Cross First School and Middle School.

### **Mobile Library Service Review**

Dorset County Council are undertaking a fundamental review because of the declining use of the mobile library service. Since 1997, the use of the service has declined by 30% which is much greater than the trend in branch libraries. This is obviously a matter of concern. Four library vehicles serve 290 villages and urban communities across the county. The service is free to join and there is no charge for borrowing books. The vehicle carries a range for all ages, with an emphasis on adult stock.

A Panel, which consists of County Councillors, supported by library staff, is considering how to

maximise use of an essential service for communities, particularly those in rural areas. The Panel is evaluating current service arrangements and considering how best the service can be developed to address changes in communities alongside County Council and service objectives. For example, they wish to explore whether providing a service at other times such as Saturdays would attract new users such as families or people at work during the week.

The Panel would welcome your views on how the service can best meet local needs. A questionnaire is included with this newsletter so that you can let us know your views. Please return the questionnaire to the Parish Office at the Village Hall, Braeside Road by 30 September so we can collate all the replies and respond to the Panel.
